Deadlines for the 2022 Omnibus

In order to publish the 2022 Omnibus on time, with quality advertisements, shows and tests, we need to adhere to the following deadlines:

Camera Ready Ads (Emailed or CD) and Show Listings (Old & New) November 15, 2021
Final Edits and Judges December 1, 2021
Omnibus to printer January 1, 2022

Please submit all show listings as a .doc or .docx file.

******Please note that if the only changes needed are dates and judges from last year's listing, you can send me just the changes and not the whole file!******

Our most recent regional meeting was done by zoom call on October 5th and was very productive in our discussions. Thank you Lendon Gray for providing the zoom! Since this report is mainly about the meeting, here are the minutes:

7:05pm - Call to order!

Director Report: Virtual convention – not what the delegates from Region 8 wanted. They did request to have zoom calls for various groups ie. competition management or regional championships. Debra will take it to the EB. The agenda for the convention should be out shortly. Only one Regional Meeting during the convention for one hour and 30 mins where the presidential candidates speak.

At this point we are not going to schedule another meeting before the convention but if we don't finish business in that time allotted, we will schedule one later in the month.

2021 Show season – COVID-19 had a much less impact on our region's show season this year. Many shows found their numbers up and riders were out showing. NEDA Spring show was a huge success with some impact on other shows. We will keep close watch in 2022.

2022 Show Season – Beland's is dropping their recognized show, ie Memorial Day weekend and Labor Day weekend. They have been long standing show for the region.

US Dressage Finals – They are expected to happen and to be huge as not only 2021 qualified riders, but also the 2020 qualified riders are invited. JrYR will be their first year to be able to participate in the US Dressage Finals.

EB- Are there any issues from our region to bring to the Executive Board – Only issue was the one above regarding zoom 'cocktail' hour.

Financial Report – Sally reported the only income came from NEDA members donating to Region 8 on their membership application, and a small amount of interest. No other activities for the year. This brought up discussion about the JrYR account being down and did we need to invoice the riders the difference. Debra and Bobbi will look into the difference.

GMO Nominations - Kate not available

NAYC – Bobbi reported the teams were excited and happy to be at the competition. They had one large donation for the entire transportation of the team to MI. They also fund raised over \$6000 which will nearly pay for the entries.

Raising Funds - Kate, Tabled as the convention will be virtual again.

Competition Management – Anita reported that the committee had been very active putting together an educational webinar to be presented in February on various types of contracts.

Regional Championships – Beth reported that the 2021 Regional Championships were successful and that NEDA volunteers did a great job. They had 553 entries which is down from the 633 in 2019. All in all, great time for all.

Debra reported for 2022 Regional Championships were a go at Saugerties with Debra as manager, Steve Reinhardt as Secretary and HITS as the licensee.

GMO – Cindi reported on the new volunteer incentive program and how it was changed slightly so GMO board members can include their hours as well. The committee also did a survey about future educational topics and outreach.

Normally the Region dresses in a color for the Board of Governors, but with this convention being virtual that will not have the impact. Do we all still have Region 8 background?

New Business – None at this time

Spring Meeting date – I will let the new Regional Director schedule this.

Adjourn at 8:15pm with thank you to Lendon for allowing us to use her zoom account.

2021 Year-End Score Report Form

Eligibility

Only scores received at EMDA-pointed shows count towards EMDA Year-End Awards. EMDA pointed shows include those listed in the current TMDS Omnibus and designated as TMDS/EMDA. For 2021 awards, these include all dressage shows held at Infinity, Puckerbrush, and Peppergrass Farms.

You must be an EMDA member by the date of the first EMDA-pointed show for which you are reporting scores in the current year. Riders are only eligible for awards at two consecutive levels. If you qualify for three, you will forfeit your eligibility at your lowest level.

Directions for reporting scores

Only list one horse/rider combination per level per form.

Intro-First Level: Submit your top 4 scores from at least 2 shows with at least 2 judges.

Second Level & above: Submit your top 2 scores from at least 2 shows with at least 2 judges.



2021 CMDA YEAR-END AWARD REQUIREMENTS

Rider must be a current CMDA member at the time scores are earned.

Re-ride tests do NOT count toward year end awards.

All scores must be earned at shows listed in the current year's TMDS Omnibus, and be given by a judge with a rating of "L" or higher ("r", "R", "s") Horse and Rider combinations are eligible for awards at two (2) consecutive levels. Should a combination qualify for three, the scores at the lowest level will be forfeit.

Year-end scores will be calculated by the level. If four (4) scores are submitted, the two middle scores will be averaged for a final score. If two (2) scores are submitted, the two scores are averaged for a final score. A final score of 55% or higher is required to qualify for an award.

To qualify for Grand Champion, or Reserve Grand Champion, one (1) of the scores submitted must be from the highest test of the level ridden.

Riders are required to submit a CMDA score report form, as well as a copy of the front of each test. Score submissions must be post marked by November 30th of the current competition year, for award consideration.

Introductory, Training, First and Second Levels: To qualify at each level, the horse & rider combination must submit four (4) scores earned at two (2) shows from two (2) different judges. One score must be from a CMDA show.

Third and Fourth Levels: To qualify at each level, the horse & rider combination must submit two (2) scores earned at two (2) different shows from two (2) different judges. One score must be from a CMDA show.


FEI (Prix St. Georges, Intermediate, Grand Prix): To qualify at each level, the horse & rider combination must submit two (2) scores earned at two (2) shows from two (2) different judges. One score must be from a CMDA show.

Western Dressage: To qualify at a level, the horse & rider combination must submit four (4) scores earned at two (2) different shows from two (2) different judges. One score must be from a CMDA

show. Separation of divisions by junior/young rider, amateur, open and by levels will be at the discretion of the awards program manager.

Freestyles: To qualify, the horse & rider combination must submit two (2) scores earned at two (2) different shows from two (2) different judges. One score must be from a CMDA show.

Combined Test: To qualify, the horse & rider combination must submit two (2) scores earned at two (2) different shows from two (2) different judges. Due to only one CMDA show holding Combined Test classes, both scores can be from any show listed in the 2020 MDS Omnibus.

WMDA Year End Awards Guidelines for Competition Year 2021:

Due to Covid-19 concerns and restrictions WMDA will follow TMDS Options:

All the awards will be ready to be picked up or delivered by January 31, 2021.

Modified Requirements:

Intro through 2nd Level: You will need at least 4 scores from two shows and two different judges.

3rd Level and above: You will need to submit at least 2 scores from 2 shows and 2 different judges.

Medal requirements have not changed. Specials Categories have also been revised to match the above new requirements.
